Frequently Asked Questions about the Public Health Program

What degrees does the Public Health program offer?

In conjunction with the College of Health Sciences, the School of Social Ecology is administering two new majors in Public Health: A B.A. in Public Health Policy and a B.S. in Public Health Science. The B.A. in Public Health Policy provides students with a foundation of coursework in the Social and Behavioral sciences, Health Policy and Social and Behavioral Health Sciences. The B.S. in Public Health Science focuses its curriculum on Epidemiology and Genetics, Environmental and Global Health Sciences and Infectious Diseases. Both degrees provide excellent preparation for careers in the Public Health arena.

What kinds of coursework have Public Health students completed?

Students pursuing a degree in Public Health Science or Public Health Policy complete a practicum. These students have completed undergraduate courses selected from public health, biological sciences, environmental quality and environmental psychology, psychology, planning, and public policy. For those pursuing the B.S. degree, they have also completed chemistry. Practicum opportunities are being developed in all areas of public health including, but not limited to research, planning, education, and health sciences. Currently, students can participate in placements in the areas of mental and behavioral health, environmental health, general public health, urban health services, emergency and forensic health, public health policy, public health education and gerontology.

What is Practicum?

As part of their undergraduate training, all Public Health students are required to integrate a theoretical understanding of issues with appropriate, supervised experience in the field. In faculty-sponsored practicum, our students have the opportunity to apply and test knowledge gained in the classroom within the context of a public health related placement. Responsibilities must be structured to provide real learning opportunities for our students, and must be directly related to the curriculum in Public Health. All internships include both training and regular supervision at the placement site, as well as an academic project or paper that is completed under the direction of the UCI faculty sponsor. Specific placement tasks vary immensely among sites, but often involve some of the following: Contributing to the day to day activities of the organization by working on tasks related to the Public Health curriculum, developing an understanding of organizational goals, observing current public health problems and evaluating intervention strategies, creating relationships between theories learned in the classroom and practice experienced in the field and developing interpersonal and technical competencies required in the public health-oriented workplace.

How does the program work?

Students apply for practicum placements from a general listing of organizations approved by the College of Health Sciences and the School of Social Ecology, beginning with an interview with the organization representative. Practicum is restricted to Public Health Juniors and Seniors who have completed their introductory courses. Together with a placement representative, practicum activities are finalized in a written agreement between the student, faculty sponsor, and placement agency. Students receive academic credit for

their practicum, and are generally not paid by the placement organization. At the end of the placement we also ask the practicum supervisor to provide us with a brief evaluation of the student's performance, and similarly, the student evaluates the placement.

What is the time commitment required?

The optimal arrangement is to have students spend a minimum of 10 hours per week for at least ten weeks since the students must earn 100 hours for 8 units of academic credit (one academic quarter). Placement sites may request a 2 quarter commitment from students, but keep in mind that students must complete their practicum hours within the parameters of the academic quarter in which they are enrolled in practicum. Any hours completed prior to the start of or following the quarter which they are enrolled in practicum will not count toward academic credit. While students will naturally need more training at the beginning, as a general rule site supervisors can expect to spend about one hour per week providing the necessary training, direction and feedback to an intern.

Students will gain an understanding of clinical research regulations, and experience in preparing clinical research documents. Students will also receive training in the development of presentations related to the research projects, and will develop communication skills required to work with other medical and pharmaceutical professionals.
